Subject to the following conditions the Shire of Kellerberrin grants to the subscriber the right to advertise and is the platform for the purpose only to publicize appropriately. It is strictly forbidden to use this device to upload and disseminate violent, discriminating and other illegal information. The subscriber agrees to observe and comply with any and all laws, rules, regulations and ordinances involved.

### **Subscription Fees**

Fees will be invoiced accordingly by the shire and must be paid in full 1 week prior to the commencement of the subscription period. Fees will be charged in accordance with Council's current fees and charges.

### **Period of Subscription**

Advertisement is available from the beginning of the financial year, once the fees and charges have been paid in full.

### **Cancellation by Business**

Cancellations must be made by the subscriber not less than two days prior to the end of the financial year.

### **Cancellation by Shire of Kellerberrin**

The subscription may be cancelled if:

- The subscription fees and/or bond monies have not been paid.

Cancellation or termination of the subscription will not affect any right which the Shire may have to recover monies owing by the business.

### **Your Privacy**
