## **HOW TO PAY YOUR RATES**

Council has resolved to offer ratepayers the opportunity to pay their rates by one of the following options:

# **Option 1 - One Payment**

Pay in full by due date - 22<sup>nd</sup> August 2025

# **Option 2 - Two Payments**

Pay over two (2) instalments, due on the:

- 1. 22<sup>nd</sup> August 2025
- 2. 9<sup>th</sup> January 2026

# **Option 3 - Four Payments**

Pay over four (4) instalments, due on the:

- 1. 22<sup>nd</sup> August 2025
- 2. 24th October 2025
- 3. 9<sup>th</sup> January 2026
- 4. 9<sup>th</sup> March 2026

# Option 4 - Special Payment Arrangement\*

Arrangement forms must be completed and are available from the Shire office.

\*Council has recognised the hardship of some ratepayers therefore Council offers an additional payment option.

This is to allow ratepayers the opportunity to pay their 2025/26 rates in full prior to 30th June 2026 without any debt recovery actions if the payment arrangement is adhered to.

Please contact the Shire Administration Office to obtain a special payment arrangement form. Approved arrangements will be confirmed in writing.

Payments made outside of the above payment options that are received by this office will not prevent debt recovery actions on any outstanding amounts.

# **OBJECTS OF & REASONS FOR DIFFERENTIAL RATES/MINIMUM PAYMENTS**

The overall objective of the proposed rates in the 2025/26 Budget is to provide for the net funding requirements of the Shire's services, activities, financing costs and the current and future capital requirements of the Shire, after considering all other forms of revenue.

The formulation of a rating system is about achieving a means by which Council can raise sufficient revenue to pay for the services it provides. Throughout Australia, the basis of using property valuations has been found to be the most appropriate means of achieving rating equity; however, the achievement of a wholly equitable rating system for all properties, in all areas, is a difficult task if it is based on the property valuations alone. For this reason, there is refinement options made available, such as differential rating, that the Shire of Kellerberrin has elected to use.

The following are the proposed Differential General Rates and Minimum Payments for the Shire of Kellerberrin for the 2025/26 financial year, to be effective from 1 July 2025.

#### INTEREST ON OVERDUE RATES AND CHARGES

Council has resolved that late payment interest will be levied at 7% for all outstanding rates, applicable to Rates and Emergency Services Levy from the applicable due date.

#### **ARREARS RATES**

Payment of rates and service charges on any assessment may not be made by instalments if, at the due date of the first instalment, any part of a rate or service charge imposed on that land in a previous financial year remains unpaid.

#### **DEBT RECOVERY**

Council has a policy for the recovery of outstanding rates. Final Notices will be forwarded for all unpaid accounts after the expiry of the due date.

If the account remains unpaid, formal recovery action will commence to recover outstanding rates. All outstanding rates will be forwarded to the debt collection agency. Costs of any legal action will be added to your account for cost recovery.

If payment is allowed to fall into arrears for a period of three (3) years or more, Council may;

- Take the land and let it on lease,
- Sell the land,
- Have the land vested in the Local Government,
- Have the land vested in the Crown.



# OWNER AND/OR OCCUPIER INFORMATION

#### **Mobile Wheelie Bins**

Council's rubbish removal service is provided under contract by Avon Waste. Collection day for all bins (Commercial and Domestic) is on Friday. Please ensure bins are placed kerbside prior to 6am to ensure collection.

Do not leave your bin permanently kerbside as the replacement of a stolen or damaged bin will be at your expense. The bin has a serial number stamped on the side and this number is recorded against your property address. Should you vacate the house, the bin remains. Avon Waste will only collect the Shire bins allocated to your property on Councils rating system.

If you require a replacement, additional bin or bin removal please complete a bin request form available at the Administration Office or Shire of Kellerberrin website to arrange delivery/removal. Alternatively, please contact the Administration office.

#### **Waste Transfer Station**

Situated 5km south of Kellerberrin on Inverarity Road, the transfer station is open weekly from Friday to Monday 8am to 12pm,12.30pm to 5pm with a supervisor in attendance at all times.

The transfer station will **ONLY** accept household rubbish, green waste, private use engine oil and domestic items. Some building materials may be accepted with prior approval from the Manager Works and Services (charges may apply).

Councils transfer station **WILL NOT** accept tyres, concrete slabs, car batteries, fibre cement, rubber, asbestos, lighting globes, e-waste (televisions, computer screens, hard drives, keyboards), microwaves, gas bottles, fire extinguishers or industrial/commercial rubbish.

#### **Recycling Service**

Recyclable goods (cardboard, paper, glass, plastic, aluminium) can be placed in the bins provided on Leake Street (Car Park adjacent to Centenary Park) and there is also now the option to deliver aluminium, glass, and plastic to the Kellerberrin Men's Shed as part of the Containers for Change Scheme. Please FLATTEN cardboard boxes and ensure all items are empty/clean, and suitable for recycling. Bins will be emptied on a regular basis, however if you notice the bins are full, please notify the Shire office, so collection can be arranged.

#### **Animal Control**

Registrations are due November 1st each year.

Dogs over the age of three (3) months must be registered. All registrations require dogs to be microchipped. Cats over the age of six (6) months must be registered. All registrations require cats to be sterilised and microchipped.

Animals wandering at large will be impounded. Owners are subject to impounding and release fees prior to collection.

If you have an animal complaint, please call into the Shire Administration Office or website to complete a complaint form. Your complaint (anonymous if preferred) will then be forwarded on to Council's Ranger for required attention.

## **Bush Fire Control**

Landowners are responsible for ensuring that their property is fire safe.

Council will distribute Bushfire Notices in September outlining landowner requirements and the 2025/2026 Fire Season Permit Periods indicating restricted and prohibited periods. Penalties can apply if not compliant.

Harvest and Vehicle Movements Bans may be issued for the Shire of Kellerberrin during the permit period. Notifications shall be issued via SMS messaging including surrounding and adjoining Local Governments. Should you wish to be added to the SMS list please contact the Shire Administration Office.

#### **Drum Muster/Containers for Change**

The Kellerberrin Men's Shed will be conducting the Drum muster collection. Landowners are encouraged to bring their empty clean chemical drums for collection. Please contact the Men's shed for further information.

The Men's Shed are now also a refund point for the Containers for Change Scheme please contact the Men's Shed directly on 0436 284 070 for opening hours and further information regarding this scheme.

#### How are rates calculated?

Your rate amount is calculated by multiplying your property's Grose Rental Value (GRV) or Unimproved Value (UV) by the rate in the dollar set by Council. The rate in the dollar is set by Council, in accordance with Councils adopted Long Term Financial Plan.

#### What is GRV and UV?

GRV (Gross Rental Value) is a valuation of your property, determined by the Valuer General. GRV valuations are reviewed every five (5) years with the next review due 2030/31 for residential, commercial and industrial land. UV (Unimproved Value) is also determined by the Valuer General and is reviewed annually. The increase in valuations for 2025/26 was 20.4% from the 2024/25 financial year. Ratepayers have the right to object to their valuation. More information can be found at www.landgate.wa.gov.au

#### How do I change my postal address?

Notification must be in writing. A Change of Details Form is available from the Shire Administration Office or by emailing shire@kellerberrin.wa.gov.au. Return the completed form by email to shire@kellerberrin.wa.gov.au, post to PO Box 145 Kellerberrin WA 6410 or by hand to the Shire Administration Office at 110 Massingham Street, Kellerberrin.

#### What is the Emergency Services Levy?

The Emergency Services Levy (ESL) is a compulsory charge for all property owners, issued by the State Government. The ESL funds WA's fire and emergency services including fire stations, volunteer fire brigades, State Emergency Services (SES) units and the Volunteer Marine Rescue Service. Local Governments are required to include the levy in their rates accounts and collect it on behalf of the Department of Fire and Emergency Services (DFES). ESL charges are calculated based on several criteria including the ESL category your property falls under and your property's Gross Rental Value, subject to minimums and maximums.

# **SENIORS & PENSIONERS**

Pensioners and Seniors may be eligible for a rates rebate. To receive a rebate, a person must hold one of more of the appropriate Pensioner or Seniors cards, and on 1<sup>st</sup> July of the financial year, own and occupy the residential property as their principal place of residence. Receive up to 50% rebate limited to a maximum (capped) amount of \$750.

Commonwealth Seniors Health Card together with a WA Seniors Card Receive up to 50% rebate limited to a maximum (capped) amount of \$750.




