**Committee:** Roadworks Advisory Committee

#### Responsible Officer: Manager of Works Services

#### 1. INTRODUCTION

The Council of the Shire of Kellerberrin has established a Roadworks Advisory Committee under the powers given in Section 5.8 of the *Local Government Act 1995* (The Act).

The Roadworks Advisory Committee is established for the purpose of assisting the Council to undertake its role under Section 2.7(2)(a) of the Act to establish and maintain liaison between stakeholders, consider policies associated with the roadworks and oversee development and maintenance of the road networks within the district.

The Roadworks Advisory Committee consists of two elected members appointed by the Council for a term ceasing on the day preceding the ordinary elections held every alternate year. At the first meeting after the ordinary elections, Council shall appoint members for a further term.

#### 2. OBJECTIVE

The objectives of the Roadworks Committee are:

- 2.1 To foster liaison and cooperation between the Shire of Kellerberrin and stakeholders associated with the road networks within the district
- 2.2 To provide a normalised, proper and formalised forum for the discussion of issues and the formulation of suggestions and/or recommendations on issues associated with the roadworks and maintenance.
- 2.3 Make recommendations to Council on matters associated with the future development and maintenance of roads.

#### 3. MEMBERSHIP

Two elected members, two Shire officers and up to eight community members shall be appointed to the Committee with an additional two elected members appointed as deputy members.

#### 4. PRESIDING MEMBER

The Committee shall appoint a Presiding Member and Deputy Presiding Member to conduct its business. The Presiding Member shall ensure that minutes of the proceedings are kept and that business is conducted in accordance with the *Shire of Kellerberrin Local Government (Council Meetings) Local Law 2016* and this document.

#### 5. MEETINGS

The Committee shall meet at least quarterly and shall report to Council quarterly as a minimum.

5.1 Notice of meetings shall be given to members at least three days prior to each meeting.

- 5.2 If any member is absent from three consecutive meetings without leave of the Committee, they shall forfeit their position on the Committee. The Council shall be informed, who will then appoint a replacement for the balance of the member's term of appointment.
- 5.3 The Presiding Member shall ensure that minutes of all meetings are kept in accordance with the *Shire of Kellerberrin Local Government (Council Meetings) Local Law 2016* and presented to Council where all recommendations will be considered.
- 5.4 All members of the Committee shall have one vote. If the vote of the members present is equally divided, the person presiding shall cast a second vote.

#### 6. QUORUM

Quorum for a meeting shall be at least 50% of the number of offices, whether vacant or not. A recommendation of the Committee does not have effect unless it has been made by a simple majority.

#### 7. DELEGATED POWERS

The Roadworks Advisory Committee has been established as an Advisory Committee only and does not have any delegated powers.

#### 8. TERMINATION OF COMMITTEE

Termination of the Committee shall be:

- (a) In accordance with the Local Government Act 1995; and
- (b) By a decision of Council.

#### 9. AMENDMENT TO THE TERMS OF REFERENCE

This document may be altered at any time by the Council.

The concept of the report will be that every action from Council's Roadworks Committee Meetings will be placed into the Status Report and only when the action is fully complete can the item be removed from the register. However the item is to be presented to the next Committee Meeting shading the item prior to its removal.

This provides the committee with an explanation on what has occurred to complete the item and ensure they are happy prior to this being removed from the report.

#### TEN YEAR FINANCIAL PLAN

There is no direct impact on the long term financial plan.

#### FINANCIAL IMPLICATIONS

Financial implications will be applicable depending on the decision of Council. However this will be duly noted in the Agenda Item prepared for this specific action.

#### STATUTORY IMPLICATIONS

Local Government Act 1995 (as amended)

5.60. When person has an interest

For the purposes of this Subdivision, a relevant person has an interest in a matter if either —

- (a) the relevant person; or
- (b) a person with whom the relevant person is closely associated,

has —

- (c) a direct or indirect financial interest in the matter; or
- (d) a proximity interest in the matter.

[Section 5.60 inserted by No. 64 of 1998 s. 30.]

#### 5.60A. Financial interest

For the purposes of this Subdivision, a person has a financial interest in a matter if it is reasonable to expect that the matter will, if dealt with by the local government, or an employee or committee of the local government or member of the council of the local government, in a particular way, result in a financial gain, loss, benefit or detriment for the person.

[Section 5.60A inserted by No. 64 of 1998 s. 30; amended by No. 49 of 2004 s. 50.]

#### 5.60B. Proximity interest

- (1) For the purposes of this Subdivision, a person has a proximity interest in a matter if the matter concerns
  - (a) a proposed change to a planning scheme affecting land that adjoins the person's land;
  - (b) a proposed change to the zoning or use of land that adjoins the person's land; or
  - (c) a proposed development (as defined in section 5.63(5)) of land that adjoins the person's land.
- (2) In this section, land (the proposal land) adjoins a person's land if
  - (a) the proposal land, not being a thoroughfare, has a common boundary with the person's land;
  - (b) the proposal land, or any part of it, is directly across a thoroughfare from, the person's land; or
  - (c) the proposal land is that part of a thoroughfare that has a common boundary with the person's land.
- (3) In this section a reference to a person's land is a reference to any land owned by the person or in which the person has any estate or interest.

5.61. Indirect financial interests

A reference in this Subdivision to an indirect financial interest of a person in a matter includes a reference to a financial relationship between that person and another person who requires a local government decision in relation to the matter.

#### 5.62. Closely associated persons

- (1) For the purposes of this Subdivision a person is to be treated as being closely associated with a relevant person if
  - (a) the person is in partnership with the relevant person; or
  - (b) the person is an employer of the relevant person; or
  - (c) the person is a beneficiary under a trust, or an object of a discretionary trust, of which the relevant person is a trustee; or
  - (ca) the person belongs to a class of persons that is prescribed; or
  - (d) the person is a body corporate
    - (i) of which the relevant person is a director, secretary or executive officer; or
    - (ii) in which the relevant person holds shares having a total value exceeding
      - (I) the prescribed amount; or
      - (II) the prescribed percentage of the total value of the issued share capital of the company,

whichever is less; or

- (e) the person is the spouse, de facto partner or child of the relevant person and is living with the relevant person; or
- (ea) the relevant person is a council member and the person
  - (i) gave a notifiable gift to the relevant person in relation to the election at which the relevant person was last elected; or
  - (ii) has given a notifiable gift to the relevant person since the relevant person was last elected;or

- (eb) the relevant person is a council member and since the relevant person was last elected the person
  - (i) gave to the relevant person a gift that section 5.82 requires the relevant person to disclose; or
  - (ii) made a contribution to travel undertaken by the relevant person that section 5.83 requires the relevant person to disclose; or
  - (f) the person has a relationship specified in any of paragraphs (a) to (d) in respect of the relevant person's spouse or de facto partner if the spouse or de facto partner is living with the relevant person.
- (2) In subsection (1) —

**notifiable gift** means a gift about which the relevant person was or is required by regulations under section 4.59(a) to provide information in relation to an election;

value, in relation to shares, means the value of the shares calculated in the prescribed manner or using the prescribed method.

- 5.63. Some interests need not be disclosed
  - (1) Sections 5.65, 5.70 and 5.71 do not apply to a relevant person who has any of the following interests in a matter
    - (a) an interest common to a significant number of electors or ratepayers;
    - (b) an interest in the imposition of any rate, charge or fee by the local government;
    - (c) an interest relating to a fee, reimbursement of an expense or an allowance to which section 5.98, 5.98A, 5.99A, 5.100 or 5.101(2) refers;
    - (d) an interest relating to the pay, terms or conditions of an employee unless ---
      - (i) the relevant person is the employee; or
      - (ii) either the relevant person's spouse, de facto partner or child is the employee if the spouse, de facto partner or child is living with the relevant person;
    - [(e) deleted]
    - (f) an interest arising only because the relevant person is, or intends to become, a member or office bearer of a body with non-profit making objects;
    - (g) an interest arising only because the relevant person is, or intends to become, a member, office bearer, officer or employee of a department of the Public Service of the State or Commonwealth or a body established under this Act or any other written law; or
    - (h) a prescribed interest.
  - (2) If a relevant person has a financial interest because the valuation of land in which the person has an interest may be affected by
    - (a) any proposed change to a planning scheme for any area in the district;
    - (b) any proposed change to the zoning or use of land in the district; or
    - (c) the proposed development of land in the district,

then, subject to subsection (3) and (4), the person is not to be treated as having an interest in a matter for the purposes of sections 5.65, 5.70 and 5.71.

- (3) If a relevant person has a financial interest because the valuation of land in which the person has an interest may be affected by
  - (a) any proposed change to a planning scheme for that land or any land adjacent to that land;

- (b) any proposed change to the zoning or use of that land or any land adjacent to that land; or
- (c) the proposed development of that land or any land adjacent to that land,

then nothing in this section prevents sections 5.65, 5.70 and 5.71 from applying to the relevant person.

- (4) If a relevant person has a financial interest because any land in which the person has any interest other than an interest relating to the valuation of that land or any land adjacent to that land may be affected by
  - (a) any proposed change to a planning scheme for any area in the district;
  - (b) any proposed change to the zoning or use of land in the district; or
  - (c) the proposed development of land in the district,

then nothing in this section prevents sections 5.65, 5.70 and 5.71 from applying to the relevant person.

(5) A reference in subsection (2), (3) or (4) to the development of land is a reference to the development, maintenance or management of the land or of services or facilities on the land.

5.65. Members' interests in matters to be discussed at meetings to be disclosed

- (1) A member who has an interest in any matter to be discussed at a council or committee meeting that will be attended by the member must disclose the nature of the interest
  - (a) in a written notice given to the CEO before the meeting; or
  - (b) at the meeting immediately before the matter is discussed.

Penalty: \$10 000 or imprisonment for 2 years.

- (2) It is a defence to a prosecution under this section if the member proves that he or she did not know
  - (a) that he or she had an interest in the matter; or
  - (b) that the matter in which he or she had an interest would be discussed at the meeting.
- (3) This section does not apply to a person who is a member of a committee referred to in section 5.9(2)(f).
- 5.66. Meeting to be informed of disclosures

If a member has disclosed an interest in a written notice given to the CEO before a meeting then —

- (a) before the meeting the CEO is to cause the notice to be given to the person who is to preside at the meeting; and
- (b) at the meeting the person presiding is to bring the notice and its contents to the attention of the persons present immediately before the matters to which the disclosure relates are discussed.

5.67. Disclosing members not to participate in meetings

A member who makes a disclosure under section 5.65 must not —

(a) preside at the part of the meeting relating to the matter; or

(b) participate in, or be present during, any discussion or decision making procedure relating to the matter,

unless, and to the extent that, the disclosing member is allowed to do so under section 5.68 or 5.69.

Penalty: \$10 000 or imprisonment for 2 years.

5.68. Councils and committees may allow members disclosing interests to participate etc. in meetings

- (1) If a member has disclosed, under section 5.65, an interest in a matter, the members present at the meeting who are entitled to vote on the matter
  - (a) may allow the disclosing member to be present during any discussion or decision making procedure relating to the matter; and
  - (b) may allow, to the extent decided by those members, the disclosing member to preside at the meeting (if otherwise qualified to preside) or to participate in discussions and the decision making procedures relating to the matter if
    - (i) the disclosing member also discloses the extent of the interest; and
    - (ii) those members decide that the interest
      - (I) is so trivial or insignificant as to be unlikely to influence the disclosing member's conduct in relation to the matter; or
      - (II) is common to a significant number of electors or ratepayers.
- (2) A decision under this section is to be recorded in the minutes of the meeting relating to the matter together with the extent of any participation allowed by the council or committee.
- (3) This section does not prevent the disclosing member from discussing, or participating in the decision making process on, the question of whether an application should be made to the Minister under section 5.69.

5.69. Minister may allow members disclosing interests to participate etc. in meetings

- (1) If a member has disclosed, under section 5.65, an interest in a matter, the council or the CEO may apply to the Minister to allow the disclosing member to participate in the part of the meeting, and any subsequent meeting, relating to the matter.
- (2) An application made under subsection (1) is to include
  - (a) details of the nature of the interest disclosed and the extent of the interest; and
  - (b) any other information required by the Minister for the purposes of the application.
- (3) On an application under this section the Minister may allow, on any condition determined by the Minister, the disclosing member to preside at the meeting, and at any subsequent meeting, (if otherwise qualified to preside) or to participate in discussions or the decision making procedures relating to the matter if —
  - (a) there would not otherwise be a sufficient number of members to deal with the matter; or
  - (b) the Minister is of the opinion that it is in the interests of the electors or ratepayers to do so.
- (4) A person must not contravene a condition imposed by the Minister under this section. Penalty: \$10 000 or imprisonment for 2 years.

5.69A. Minister may exempt committee members from disclosure requirements

- (1) A council or a CEO may apply to the Minister to exempt the members of a committee from some or all of the provisions of this Subdivision relating to the disclosure of interests by committee members.
- (2) An application under subsection (1) is to include —

- (a) the name of the committee, details of the function of the committee and the reasons why the exemption is sought; and
- (b) any other information required by the Minister for the purposes of the application.
- (3) On an application under this section the Minister may grant the exemption, on any conditions determined by the Minister, if the Minister is of the opinion that it is in the interests of the electors or ratepayers to do so.
- (4) A person must not contravene a condition imposed by the Minister under this section.

Penalty: \$10 000 or imprisonment for 2 years.

5.70. Employees to disclose interests relating to advice or reports

(1) In this section —

employee includes a person who, under a contract for services with the local government, provides advice or a report on a matter.

- (2) An employee who has an interest in any matter in respect of which the employee is providing advice or a report directly to the council or a committee must disclose the nature of the interest when giving the advice or report.
- (3) An employee who discloses an interest under this section must, if required to do so by the council or committee, as the case may be, disclose the extent of the interest. Penalty: \$10 000 or imprisonment for 2 years.

Please find below a report regarding works that have been completed, being completed and upcoming jobs or issues that are current for the Shire of Kellerberrin.

Since the last meeting the Shire crews have been busy with various jobs that were scheduled and unscheduled work.

The crew have done maintenance grading, redo maintenance grading work due to rain event, culvert repairs, tree pruning, road side clearing, road construction, gravel sheeting, pot hole repairs.

The above has had its challengers over the months with delays in machinery repairs from suppliers and finding subcontractors to fill the spots difficult to find.

#### MARCH COUNCIL MWS REPORT 2023

#### Road crew

Road crew have been busy completing the construction of Doodlakine South road and the sealing has been completed. The asphalt sections will be done early March and all other minor jobs like signage and guild post will be completed.

The crew have also restarted the construction of Goldfields road and we hope to have this completed and ready for wet mixing by the end of March.

With the availability of haulage subcontractors throughout the state has hindered some progress.

There has also been some quick dry grading maintenance completed on some school routes.

#### APRIL COUNCIL MWS REPORT 2023

#### **Road Crew**

Road crew have completed the construction of Doodlakine South road, they also assisted in town work when staffing numbers in town were low.

There was also some maintenance grading completed.

The crew then restarted the construction of the Goldfields road and we hoped to have this completed and ready for wet mixing by the end of March. Unfortunately the clearing permit has not been granted to date so all further works have stopped until this has been granted.

- (1) A rate or service charge is ordinarily payable to a local government by a single payment but the person liable for the payment of a rate or service charge may elect to make that payment to a local government, subject to subsection (3), by

- (3) A local government may impose an additional charge (including an amount by way of interest) where payment of a rate or service charge is made by instalments and that additional charge is, for the purpose of its recovery, taken to be a rate or service charge, as the case requires, that is due and payable.
- (4) Regulations may
  - (a) provide for the manner of making an election to pay by installments under subsection (1) or (2);
  - (b) prescribe circumstances in which payments may or may not be made by installments;
  - (c) prohibit or regulate any matters relating to payments by installments;
  - (d) provide for the time when, and manner in which, installments are to be paid;
  - (e) prescribe the maximum amount (including the maximum interest component) which may be imposed under subsection (3) by way of an additional charge; and
  - (f) provide for any other matter relating to the payment of rates or service charges.

#### 6.46. Discounts

Subject to the *Rates and Charges (Rebates and Deferments) Act 1992*, a local government may, when imposing a rate or service charge, resolve\* to grant a discount or other incentive for the early payment of any rate or service charge.

#### 6.2. Local government to prepare annual budget

(1) During the period from 1 June in a financial year to 31 August in the next financial year, or such extended time as the Minister allows, each local government is to prepare and adopt\*, in the form and manner prescribed, a budget for its municipal fund for the financial year ending on the 30 June next following that 31 August.

- (3) For the purposes of subsections (2)(a) and (b) all expenditure, revenue and income of the local government is to be taken into account unless otherwise prescribed.
- (4) The annual budget is to incorporate
  - (a) particulars of the estimated expenditure proposed to be incurred by the local government;
  - (b) detailed information relating to the rates and service charges which will apply to land within the district including
    - (i) the amount it is estimated will be yielded by the general rate; and
    - (ii) the rate of interest (if any) to be charged by the local government on unpaid rates and service charges;
  - (c) the fees and charges proposed to be imposed by the local government;
  - (d) the particulars of borrowings and other financial accommodation proposed to be entered into by the local government;
  - (e) details of the amounts to be set aside in, or used from, reserve accounts and of the purpose for which they are to be set aside or used;
  - (f) particulars of proposed land transactions and trading undertakings (as those terms are defined in and for the purpose of section 3.59) of the local government; and
  - (g) such other matters as are prescribed.
- (5) Regulations may provide for
  - (a) the form of the annual budget;
  - (b) the contents of the annual budget; and
  - (c) the information to be contained in or to accompany the annual budget.

#### BACKGROUND

Council's Chief Executive Officer on Tuesday 28<sup>th</sup> November 2023 received the following email from Mr Joe Fondacaro, Managing Director, Mineral Crushing Services (WA), Doodlakine Quarry.

#### Good afternoon Raymond,

We are requesting that the Shire of Kellerberrin place a traffic counter on Mather Road to the Doodlakine Quarry.

I have been advised by several Shires that there is funding available for bitumising and upgrading of roads used by heavy vehicles .

We would fall into this category with the volume of vehicular traffic to our quarry.

MCS has contributed to the maintenance of Mather for over 5 years with supply of cracker dust and road base and grading .

Mather Road does need some serious attention to it as the gravel surface is no longer there in large sections , this is causing issues in winter as the road becomes very slippery and is a danger to all of the road users .

In the summer and dry periods there is a serious dust issue and also becomes very corrugated causing damage to road users vehicles .

We did offer the Shire the aggregate to use for the sealing of the road, but this was rejected.

We will make this offer once again to help offset the costs.

Can we please put this forward to this months council meeting.

#### STAFF COMMENT

With regards to the above email request please note the following comments;

#### ROAD FUNDING

Council is aware of the following funding types and the allocation of funding for them;

- RRG Regional Road Group This funding is for upgrading/maintaining roads that are included on the 2040 road network which is approved by Main Roads WA. Mather Road is on this network.
- RTR Roads to Recovery This funding is at the discretion of Council. This funding is generally used for all other roads that aren't on the 2040 listing (RRG) to enable upgrades/maintaining the full network.
- Commodity Route Funding This funding is to upgrade roads for additional commodities being transported. This request is on the basis of one other commodity which as administration we feel won't be supported by Main Roads.
- HVSPP Heavy Vehicle Safety Productivity Program

The Australian Government's Bridges Renewal Program (BRP) and Heavy Vehicle Safety and Productivity Program (HVSPP) are designed to provide funding to State, Territory and Local Governments for projects which will:

- upgrade and replace bridges to enhance access for local communities and facilitate higher productivity vehicle access (BRP) and;
- increase the productivity and safety of heavy vehicle operations (HVSPP), including new and upgraded rest areas through the new Heavy Vehicle Rest Areas initiative (HVRA).

#### What projects are eligible?

To be eligible, the project must meet the following requirements:

*Must be an improvement, not maintenance:* The Australian Government will assist in funding important improvements to your community. Projects must be an improvement to an existing road asset. The programs support projects which improve existing publicly owned road assets.

Improvement is an overall test. Project outcomes are considered as a whole. For example, a culvert could replace a bridge, if the culvert improved access and maintenance.

Improvement can include both upgrade and replacement of an existing asset.

**New:** The programs are designed to support new projects, where construction is additional to applicants' existing program of works and which would not have been possible without funding support. Therefore, projects must not have started. Applications should not be made for projects where tenders have been awarded, construction has already commenced or is likely to commence ahead of a decision being made on the application.

**Existing funded BRP/HVSPP projects:** applications that are submitted as part of a changed scope, timeframe or cost are not required to meet the requirement that a project is new.

**Accessible:** - the programs aim to improve community access and productivity. Therefore, applications should only be made for projects which are accessible to the public and associated with a public road. Projects where the final construction will be privately owned or located on a private road are ineligible.

**Road-based:** the primary purpose of each application must be to improve accessibility, safety and productivity of **road-based** projects. The only non road-based elements which are eligible under the program are those which support the primary road-based purpose. Examples of <u>eligible</u> non road-based activities include:

- a road bridge project which includes a separate pedestrian bridge where the primary aim is to improve the road bridge.
- a rest stop with functional elements such as toilets or shade areas.

Examples of *ineligible* non road-based activities include:

- rail bridges, where the rail line passes over a roadway.
- improvement to livestock marshalling areas because they are not associated with a road.

Whole and Complete: related projects can be grouped for consideration where the total costs do not exceed the per project funding limit. This may include multiple construction elements where the combination enhances the overall outcome. For example, replacement of three bridges on a single route, which would enable the mass limit for the entire route to be increased would be deemed eligible as a single project.

However, <u>artificial</u> divisions of a larger project to fit under the project funding limits will be deemed <u>ineligible</u>. For example, a project to seal a length of road cannot be sub-divided into smaller projects to seal two or more smaller sections of the same road.

**One Program only:** a single project may only be submitted for funding under either the BRP or HVSPP and cannot be submitted for both. Projects where bridge related components are less than 40% of the total project cost must be submitted under the HVSPP. Projects where the bridge related components are more than 40% must be submitted under the BRP.

**Technology trials and demonstration projects:** projects that seek to trial and demonstrate new approaches to transport, safety and productivity are eligible to apply. Technology can be installed on new or existing roads, and would not be subject to the requirement that the project is an

improvement to an existing road asset. For example, the installing of Vehicle to Infrastructure technology could take place on a new road.

The following types of projects are ineligible:

- Projects where the majority of funding is not for road based transport.
- Inspections and structural assessments.
- Projects which are for maintenance purposes.
- Design only projects.

Mather Road is listed as a funded road through the RRG program though it needs to be considered inline with other roads within the Shire and then prioritised. Please find below a list of funding programs and roads that are covered through that program;

Council currently has the following roads listed on the Wheatbelt Secondary Freight Network;

- 1. Kellerberrin-Shackleton Road
- 2. Kellerberrin-Yoting Road
- 3. Kellerberrin-Bencubbin Road
- 4. Bruce-Rock Doodlakine Road

This funding is expected to allocated to these roads from approximately 2027 onwards. The full program works hasn't been provided to Council as yet.

Councils 2040 Roads include the following;

• Baandee North Road

Full length of road reconstructed. Will require reseals completed.

• Doodlakine South Road

Full length reconstructed by the end of 2024/2025 financial year. Road requires reseals.

• Kellerberrin Shackleton Road

Roadworks to be funded through WSFN

• Kellerberrin Yoting Road

Roadworks to be funded through WSFN

Kwolyin West Road

Only the first four kilometres or so have been reconstructed on this road.

• Doodlakine Bruce Rock Road

Roadworks to be funded through WSFN

• Doodlakine Kununoppin Road

Council has only completed the first two kilometres of this road.

• Dowding Street

Fully reconstructed, will need reseals.

• Kellerberrin Bencubbin Road

Roadworks to be funded through WSFN

• Kellerberrin Yelbini Road

No work on this road, plan is for this road to be commenced in 2025/26

Scott Street

Hammond Street to boundary requires full reconstruction.

• Mather Road

No work on this road at this time.

The above summary gives an update to the committee on where we are at with roads and understanding that with current RRG levels of funding we can do approximately 2kms a year for full reconstruction.

Therefore, the commodity route and HSVPP funding it utilised to supplement these heavy vehicle routes. Previously Council has accessed HSVPP funding for the Baandee North Road and Commodity Route has been utilised on the Goldfields Road. The current program of Commodity route funding that Council is pursuing is the continuation of funding Goldfields road until completion which would be approximately another two (2) to three (3) years financial years.

#### BACKGROUND

For the committee members to raise items on the day of the Committee Meeting.

#### STAFF COMMENT

This agenda is provided for Committee members to bring up General Business items;

- Victoria Road upgrades and requirements;
- Raymond Griffiths Spoken to neighbouring landowners, still an issue with road, drainage, request for 3 gates and clearing of laneway at end. Raymond advised that this is a school bus route.
- Goldfields Road/Yelbini Road Intersection for future years funding;
- Raymond Griffiths Awaiting confirmation of funding for the next 2 years. Potential for Heavy Vehicle Safety Funding & Commodity Route Funding to complete intersections and road widening to have a merging section.
- Dennis Reid advised the route is a minimum 4 minutes quicker and will be well utilised
- Yoting Road into town;
- This is a freight network road, potential plans to re-align with Shackleton road for safety purposes. Look at alternatives and review options.
- RTR possible increase in funding.
- Raymond advised that this funding could possibly double and for members to email with 2024/25 considerations.
- Consideration of roads for the 2024/25 Budget
- Raymond Griffiths advised Regional Road Group (RRG) roads for 2024/25 will be Doodlakine South construct and reseal, and North Baandee reseal.
- Matthew Steber advised that although Yelbini Road is on hold awaiting future opportunities for funding, to proceed with the clearing permit
- Works proposal on completion of Hammond, Connelly & Sewell Street.
- Raymond advised that the footpath was scheduled to be completed week beginning 11<sup>th</sup> December 2023, although due to contractors this has now been pushed back to January 2024. Seeking alternative solution for contractor.
- Kerbing will be commencing week beginning 18<sup>th</sup> December 2023
- Plans to be submitted to Raymond prior to leave for Sewel Street project, as advised by contract engineer Rod Munns.
- Kelvin Tiller asked why was larger aggregate used on new roads. Raymond advised that this was not intended, although unfortunately 14ml/10ml mix was used rather than the planned 10ml/5ml mix.
- Kelvin asked by the Connelly Intersection is significantly lower. Raymond advised that when the intersection will be done in the future it will be fit for drainage purposes.
- Proposed Windfarm construction and impact on Council roads.

- Green Wind is meeting with Council post Council Meeting to discuss the potential for a project north of Kellerberrin.

#### Matt Steber

- Request from Community for a Speed limit change near Men's Shed, advised that this is Main Roads that determine speed limits.
- Johns Road Re-sheet while gravel is there and available

#### Grant Gardiner

- Mitchell Street, sides of road need maintenance grading, S bends quite bad and overgrown
